Legal grounds for preparation and adoption of plan

Preparation of the Maritime Spatial Plan of Internal Sea Waters, Territorial Sea and Exclusive Economic Zone in scale of 1: 200 000 (hereinafter: Plan) results from the provisions of the Act of 21 March 1991 on the marine areas of the Republic of Poland and maritime administration (Journal of Laws of 2018, item 2214 as amended). This Act implements the Directive 2014/89/EU of the European Parliament and of the Council of 23 July 2014 establishing a framework for maritime spatial planning, pursuant to which the EU Member States are obliged to prepare the maritime spatial plans (hereinafter: Directive 2014/89/EU) to the Polish legislation.

The *Plan* includes all internal waters, territorial sea and exclusive economic zone under the jurisdiction of the Polish maritime administration, excluding waters of seaports and of three lagoons, for which the plans in higher scale will be prepared in order to embrace specific matters therein. The *Plan* aims at supporting sustainable development of marine areas including among others by identification of the areas and determination of coexistence of different methods of marine spatial planning in order to create spatial order. The *Plan* shall be adopted by the Council of Ministers by means of a regulation and will act as a tool for the Minister competent for maritime economy to assess the requests submitted in the procedure determining compliance of the planned investments with the provisions of the marine spatial plan.

Pursuant to Article 46(1)(1) of the Act of 3 October 2008 on sharing information about the environment and its protection, public participation in environmental protection and environmental impact assessment (Journal of Laws of 2018 item 2081 as amended), the draft *Plan* is subject to strategic environmental assessment. In addition, the *Plan* is also covered by the strategic environmental assessment in transboundary context initiated in accordance with national legislation at the stage of already prepared official draft *Plan*.
