Planning Act 2008 and The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 - Regulation 32

Proposed Application by Ørsted Hornsea Project Four Limited (the Applicant) for an Order Granting Development Consent for the Hornsea Project Four **Offshore Wind Farm (the Proposed Development)**

Further to our letter dated 01 October 2019 informing you that the above proposed development was likely to have significant effects on the environment of your State, we note that you did not respond.

The Secretary of State wishes to inform you that the application for the above proposed development has now been accepted for examination and new information is available on the likely significant effects on your State. If your State wishes to participate in the process you still have an opportunity to do so, which is explained later in this letter in the "responding to this notification" paragraph.

The remaining stages of the process are:

- Pre-Examination,
- Examination (the Examining Authority has a maximum of six months to carry out the examination),
- Recommendation (three months for the Examining Authority to make a recommendation to the relevant Secretary of State),
- Decision (three months for the relevant Secretary of State to make a decision on whether to grant or refuse development consent); and
- Post-decision (six week legal challenge period).


