Dear Sir or Madam,

the Federal Maritime Authority (BSH) has been responsible for federal sectoral planning in the German Exclusive Economic Zone (EEZ) since 2011.

In 2018 and 2019, the BSH has for the first time drawn up a Site Development Plan in accordance with section 4 ff. Offshore Wind Energy Act (WindSeeG), carried out a Strategic Environmental Assessment and published the corresponding documents (FEP 2019, Environmental Reports) on 28 June 2019.

The Site Development Plan is the sectoral plan for the expansion of offshore wind energy plants and grid connections in the German Exclusive Economic Zone of the North Sea and Baltic Sea and - under certain conditions - in territorial waters. Its purpose is to achieve the statutory expansion targets for offshore wind energy by 2030, to expand electricity generation from offshore wind energy plants in a space-saving manner, to ensure the efficient use and capacity utilisation of offshore grid connections and to plan, construct, commission and use offshore grid connections in

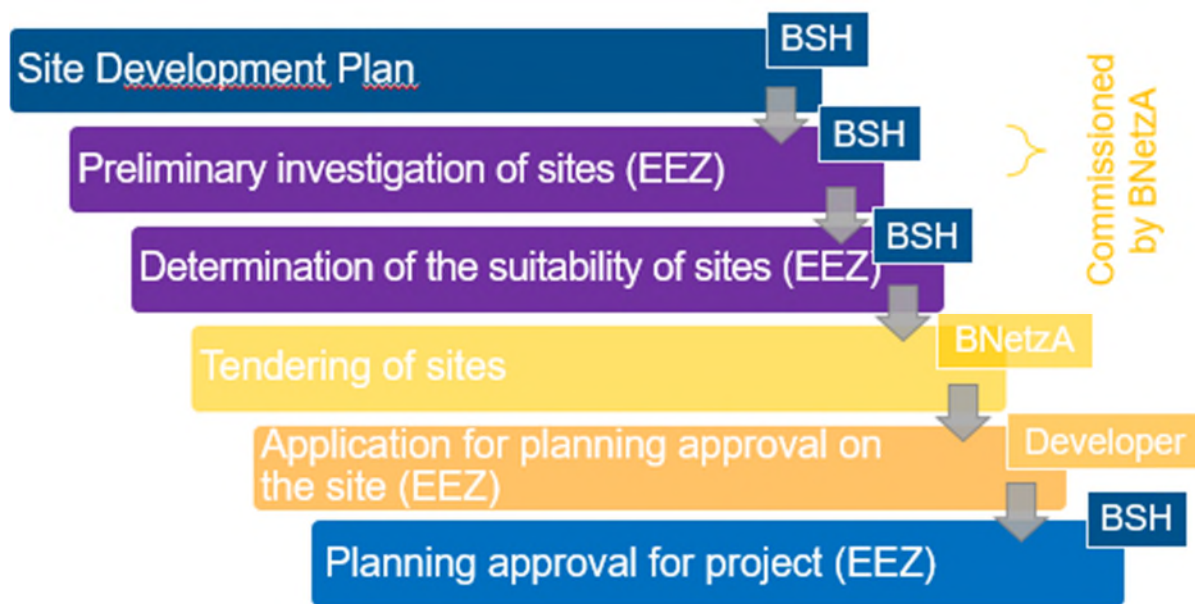

parallel with the expansion of electricity generation from offshore wind energy plants.

The Site Development Plan 2019 implements the expansion target for offshore wind energy of 15 gigawatts by 2030 in accordance with section 4 para. 2 no. 1 WindSeeG.

The Site Development Plan is only one stage in the central system of offshore wind energy expansion in the German EEZ.

The treatment of the comments and the result of the consultation can be found in Chapter 9 of the 2019 Site Development Plan.

The Strategic Environmental Assessment comes to the conclusion that, on the basis of the available data and knowledge, no significant environmental impacts and no adverse transboundary environmental impacts are to be expected (Chapter 4.13).

The avoidance, reduction and compensation measures is contained in Chapter 8 of the environmental reports for the North Sea and Baltic Sea. The summary environmental statement and the monitoring measures are provided in Chapter 9 of the environmental reports. The non-technical summary is arranged in Chapter 11 of the environmental reports for the North Sea and the Baltic Sea.

Updating and amending the Site Development Plan

On the occasion of the draft law to amend the offshore wind energy act and other regulations adopted by the Cabinet on 3 June 2020, and in particular due to the increased expansion path of 20 gigawatts of offshore wind energy by 2030 provided for therein, it is necessary to update and amend the Site Development Plan 2019.

It is intended to work on the following topics in the framework of the update and amendment of the Site Development Plan 2019:

- Spatial and temporal definition of areas for 20 GW by 2030 and areas in zone 3 of the North Sea, taking into account the update of the site development plan for the German North Sea and Baltic Sea EEZ
- Definition of requirements for the connection concept +/- 525 kV DC
- Revision of the performance assessment for zone 3 in consideration of current research results
- Spatial and temporal definition of interconnectors and platforms
- Adaptation of small-scale area definitions N-6 and N-7, e.g. 66-kV direct connection concept for NOR-6-3
- Review of the definitions of "interconnections".
- Designation of other energy production areas
- Adaptation of planning principles, including updating the provisions on the 2 C criterion
- Adaptation of the spatial definitions to the conditions resulting from the previous themes
- Informational presentation of spatial or temporal definitions beyond the period 2030 (Figure Scenario frame 2021-2035), taking into account new, potentially relevant findings.

A strategic environmental assessment will be carried out for extended and modified definitions, taking into account updates - if not already done.

As far as the legal framework conditions are available, the procedure is to be completed by the end of 2020.
